DESCRIPTION:	
Acceptance of Community Contribution Grant from the Rotary Club of Arlington for the purchase of eight (8) AED's to be deployed in Police Vehicles. The grant is for \$12,284.66 to purchase eight (8) new automated external defibrillators (AED's) for field deployment in police vehicles. Acceptance of this grant will require an end of year budget adjustment.	
HISTORY:	
In a study published in <i>The New England Journal of Medicine</i> involving security officers who were trained to use AED's in U.S. casinos, there was a 74% survival rate among adults who experienced sudden cardiac arrest if the defibrillation was delivered within three minutes. The American Heart Association estimates that placement of defibrillators in communities could save up to 100,000 lives a year. The City applied for the Community Contribution Grant from the Rotary Club of Arlington for the purchase of eight (8) AED's to be deployed in Police Vehicles in 2017 and received notice of the award in March of 2018.
