AGREEMENT TERMINATING INTERLOCAL AGREEMENT

WHEREAS, the City of Arlington and the Arlington Transportation Benefit District previously entered into an agreement entitled "An Interlocal Agreement Between the City of Arlington, Washington and the Arlington Transportation Benefit District", which agreement was signed on May 6, 2013; and

WHEREAS, the agreement provided for its termination upon the agreement of both parties; and

WHEREAS, the parties are in agreement that it is in the best interests of the citizens to terminate said Agreement and for the City to assume the responsibilities of the District, making the Interlocal unnecessary;

NOW THEREFORE, the parties do hereby agree as follows:

That certain agreement entitled "An Interlocal Agreement Between the City of Arlington, Washington and the Arlington Transportation Benefit District", which agreement was signed on May 6, 2013, shall be and hereby is terminated and of no further force and effect, effective upon the assumption by the City of Arlington of the responsibilities of the District pursuant to RCW Chapter 36.74.


