Project Description: The proposed binding site plan is located at 20015 67th Avenue NE in Arlington, Washington, on an approximately 52.2 acre site. The proposal is for the creation of seven (7) lots for a business park with uses permitted in the General Industrial Zone. Specific Building sizes are not known at this time. A local roadway built in conjunction with this project will allow for access connecting between 67th Avenue NE and Arlington Valley Road. **City Approvals Required:** Special Use Permit, SEPA, Design Review, Civil Permit, Utility Permit, Building Permits. **Other Agencies Approvals Required:** Department of Ecology Stormwater General Construction Permit, Puget

Sound Air Quality Permit.

Studies Required: Drainage Report, Geotechnical Report, Traffic Impact Analysis, SEPA Checklist **Comment Period** There is a 14-day comment period for the Special Use Permit application.
