**Proposal Description:** The 2026 Preliminary Annual Docket is a list of proposed amendments to the City’s Comprehensive Plan, Zoning Map and/or Development Regulations for the upcoming year and serves as a work plan. Under state law, comprehensive plans can only be amended once annually. Arlington chooses to process and consider all proposed changes for a given year concurrently. Once the preliminary annual docket is reviewed by the Planning Commission at a public hearing, the Planning Commission makes a recommendation to the City Council on which docket items should be placed on the Final Annual Docket. Approval of the Final Annual Docket is required by the City Council. The approval of the Final Annual Docket does not mean approval of the proposed items; it only provides approval to work on the proposed items. Approval of each docket item is required separately through Planning Commission recommendation and City Council approval on a future date. **Testimony:** Any interested person has the right to submit written testimony to the City regarding this action as well as the right to appear at the public hearing and give oral testimony. Written testimony must be submitted by 5:00 pm on October 20, 2025, to the staff contact listed above.

**Approvals Required:** City Council

**To Appeal Decision:** Only persons who submit written testimony or oral testimony to the permit-issuing authority may appeal any decision regarding this proposal.
