Project Description: The proposed Gilman Walk at Country Charm and SMARTCAP 188th St. Development projects have proposed Development Agreements that require City Council approval. The Development Agreements include improvements to city owned properties, future dedications of right-of-way and improvements to said right-of-ways. The individual projects will have separate hearings based on their proposals, which will occur back to back in order to facilitate discussion for City Council.

<u>Testimony</u>: All persons have the right to submit written testimony to the appropriate permit-issuing authority and to appear at the public hearing to give testimony orally. In order to follow Governor Inslee's Proclamation 20-28, meetings are conducted via Zoom, the Record of the hearing will be extended for two (2) days after the hearing to allow for public comment.

<u>To Appeal a Decision</u>: When the City has issued a notice of decision and all reconsideration periods have expired, the decision shall be final and may be appealed only to the Snohomish County Superior Court within twenty-one (21) calendar days from the date of the final decision. All appeals must clearly state the alleged errors of fact or law and include a specific request for relief. Only parties of record may appeal a decision.

To Become a Party of Record: You may become a party of record by submitting written comments and requesting to become a party of record to the Community and Economic Development Department, by entering your name on a sign-up registry at the Public Hearing, or testify at the Public Hearing.
